FIRST AMENDMENT

CONTRACT FOR ENGINEERING SERVICES
FOR
DOUGLAS COUNTY HYDRAULIC MODELING IDIQ
A CONTRACT BETWEEN
DOUGLAS COUNTY, NEVADA
AND
HDR ENGINEERING, INC.

THIS FIRST AMENDMENT to THE ORIGINAL CONTRACT FOR ENGINEERING SERVICES (“CONTRACT”) IS ENTERED INTO BY AND BETWEEN DOUGLAS COUNTY, NEVADA, A POLITICAL SUBDIVISION OF THE STATE OF NEVADA (“COUNTY”), AND HDR ENGINEERING, INC. (“CONTRACTOR”). THE COUNTY AND CONTRACTOR ARE AT TIMES COLLECTIVELY REFERRED TO HEREINAFTER AS THE “PARTIES” OR INDIVIDUALLY AS THE “PARTY.”

WHEREAS, on May 3rd, 2018 Douglas County entered into a Contract for professional services with the Contractor, which was recorded with the Douglas County Recorder as Document No. 2018-913887; and

WHEREAS, the existing contract is set to expire on May 3, 2022 and the County intends to have HDR continue providing its modeling services on behalf of the County; and

WHEREAS, the Parties now desire to enter into this First Amendment to the May 3, 2018 Contract for engineering services with the Contractor in order to extend out the contract time and modify the Contractor’s hourly billing rates as set forth herein.


NOW, THEREFORE, based on good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and the mutual promises and conditions contained herein, the Parties agree to amend the Original Contract as follows:

- 1. EFFECTIVE DATE OF CONTRACT.** The Parties agree that the Contract time shall be extended until December 31, 2026, unless this Amended Contract is terminated earlier in accordance with the terms of the Original Contract.

PAYMENT FOR SERVICES. The Parties agree to use the Contractor’s current hourly rates included as Exhibit A for billing purposes which is incorporated into the Contract. The Contractor may submit an update to their hourly rates on an annual basis on or before May 3rd of each year. If the hourly rates are not updated prior to May 3rd, the hourly rates used in the previous year shall apply. Douglas County reserves the right to approve the rates or request modifications to the rates.


