AMENDED LETTERS TESTAMENTARY





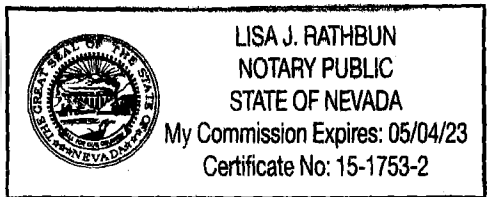
