GRANT, BARGAIN AND SALE DEED

THIS DEED is made this 29th day of Dec., 2021, by and between **ARMANDO P. CONDE AND DIVINIA S. CONDE, HUSBAND AND WIFE AS JOINT TENANTS AS TO AN UNDIVIDED ½ INTEREST AND MARIO B. INES AND DIANE S. TOGETHER WITH all the improvements now or hereafter erected on the property, and all easements, rights, appurtenances, rents, royalties, mineral, oil and gas rights and profits, water rights and stock and all fixtures now or hereafter a part of the Property. All replacements and additions shall also be covered by this Deed. All of the foregoing together with all personal property associated therewith is part of the Property described above.
