JUNE 18, 2020 CONTRACT FOR SERVICES BY AN INDEPENDENT CONTRACTOR

between

DOUGLAS COUNTY, NEVADA

and

RENO-TAHOE CONSTRUCTION, INC.

This Contract Amendment No. 002 ("Amendment") is entered into by and between Douglas County, Nevada, a political subdivision of the State of Nevada ("the County") and Reno-Tahoe Construction, Inc., a Nevada Domestic Corporation registered with the Nevada Secretary of State ("Contractor"). The County and Contractor are at times collectively referred to hereinafter as the "Parties" or individually as a "Party."

WHEREAS, on June 18, 2020, the County, and Contractor, entered into a contract to provide construction services to replace one hundred (100) linear feet of water main and a fire hydrant including all appurtenances; and

WHEREAS, in approving the Contract on June 18, 2020, the Douglas County Board of County Commissioners authorized the County Manager and/or Director of Public Works to execute any necessary changes to the Contract within 10% of the authorized amount; and

WHEREAS, the Parties modified the 2020 Contract in order to have Contractor provide additional work, as more particularly set forth and described in Exhibit A-1 of Contract Amendment No. 001 and increased the contract by \$19,645.66 for a total contract amended amount of \$69,395.66.

WHEREAS, the Parties wish to modify the 2020 Contract for a total reduction of \$1,000 instead of requiring Contractor to perform certain repairs to driveway pavers.

NOW, THEREFORE, in consideration of the agreements herein made, the Parties mutually agree as follows:

- 1. <u>Definitions</u>: Unless otherwise specifically set forth herein, the words and phrases contained in this Amendment shall have the meanings ascribed to them in the June 18, 2020 Contract.
- 2. The total Contract Price, as amended in Amendment No. 1, of \$69,395.66 will be reduced by \$1,000, for a final contract price of \$68,395.66
- 3. The Contract Price is being reduced instead of requiring the Contractor to repair a small section of sunken pavers in the driveway. Upon execution of this Amendment, the work under the original contract will be considered complete.
- 4. All other terms and conditions of the original Contract remain unchanged and in full effect.
