5. Statutory interest has accrued at the statutory rate from the date of July 5, 2016 in the amount of \$1,068.61.

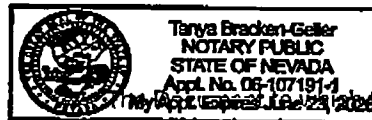
- 1 6. Since the entry of judgment, Plaintiff has accrued costs in the amount of \$276.00.

- 13 \$4,881.16, and Plaintiff will incur additional certification and recording fees as enumerated
