This CLAIM OF LIEN FOR DELINQUENT ASSESSMENTS is being given to

that Ridge Crest Property Owners' Association, a Nevada nonprofit corporation ("Association"), is owed assessments in the amount of **\$4,491.80** with interest and fees, which are past due pursuant to Declaration of Timeshare Covenants, Conditions, and Restrictions for the Ridge Crest recorded April 27, 1989 as Document No. 200951 of Official Records, Douglas County, State of Nevada, as may be amended, supplemented, and amended and restated from time to time (collectively the "**Declaration**");

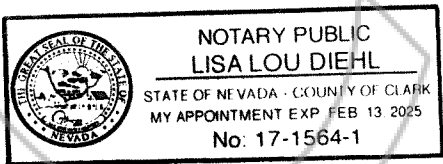
