GRANT, BARGAIN AND SALE DEED

THIS DEED is made this 26 day of MAY, 2022, by and between **Thomas E. Seltz and Norma J. Seltz, Trustees of the Thomas E. Seltz and Norma J. 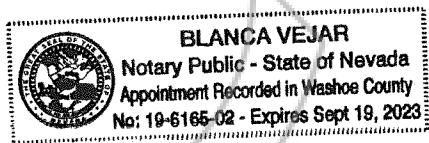
