The Court finds and concludes that the Decedent's heirs are his two children, David

- Medicaid Estate Recovery, have been provided with proper notice of the hearing conducted on the Personal Representative's Petition. A Notice of Hearing was filed 18 July 2019. The Court finds, concludes and orders that Notice of Hearing and the Petition were properly served by the Personal Representative.
- The Court finds and concludes that the Decedent's real property was sold pursuant to 4. its Order Confirming Sale of Real Property and Payment of Costs entered 7 January 2019. The Personal representative received the proceeds of such sale. There is now a balance of \$681,048.61 on deposit in the Decedent's Bank of America checking account. The Personal Representative has requested approval of distribution of the account's proceeds in equal shares to the Decedent's beneficiaries, his two children, namely David Neal Moline and Dawn E. McCoy. It is hereby the order of the Court that Petitioner's request to distribute the Decedent's estate into equal shares to David Neal Moline and Dawn E. McCoy shall be ratified, confirmed and approved.
- 5. The Executor has requested authorization to execute two Executor's deeds conveying 1698 Mackland Avenue, Minden, Nevada to David Neal Moline, and 1696 Mackland Avenue, Minden, Nevada to Dawn E. McCoy. This request is ratified, confirmed and approved and the Executor shall convey the properties as the Decedent provided in his Last Will and Testament.

- 6. Pursuant to NRS 150.020, the Personal Representative is entitled to ordinary commissions on the estate which he has administered. The Personal Representative set forth his intention to waive any claim to his statutory compensation in his Petition filed 18 July 2019. The Personal Representative's waiver of statutory compensation is ratified, confirmed and approved.
- 7. The Personal Representative has requested, pursuant to NRS 150.060, that the Court ratify, confirm and approve of reasonable compensation for attorney's services to be paid out of the Decedent's Estate. The Court finds that pursuant to the agreement between the Personal Representative and his counsel, the Personal Representative has paid attorney's fees invoiced in the amount of \$6,948.82. The Personal Representative has requested that the Court ratify, confirm and approve his prior payment to his counsel and that he be authorized to pay up to an additional \$1,500.00 for estimated attorney's fees which will be incurred to bring this matter to conclusion.
