The Discovery Monument is located North 51° 55 Minutes 25 Seconds east, A Distance of 3,804 feet  
 from the following natural/permanent monument: SW corner of section 27 T9N R23E

The claim is approximately 1500 feet long and 600 feet wide, such that 500 feet are claimed in a  
northeast direction and 1000 feet in a southwest direction from the point of discovery (monument of  
 location), at which the Notice of Location was posted, together with 300 feet on each side of the  
 monument of location and center line of the Claim. The general course of the lode or vein is from the  
northeast to the southwest direction.

This Notice of Location has been written to capture mineral rights within its boundaries, only on open and locatable ground. In  
 the case that some or parts of the claim boundaries overlap private or patented land it is understood that no rights or  
 ownership is implied or assumed in relation to that portion of the claim. In the case that any part of this claim boundary may

 ownership implied or assumed.



<u>No.2: S CORNER</u>	<u>S CORNER #2 Arrowhead 1</u>	<u>2" x 2" WOODEN POST</u>
<u>No.3: W CORNER</u>	<u>W CORNER #3 Arrowhead 1</u>	<u>2" x 2" WOODEN POST</u>
<u>No.4: N CORNER</u>	<u>N CORNER #4 Arrowhead 1</u>	<u>2" x 2" WOODEN POST</u>

 consisted of making a claim map as provided in NRS 517.040.
