part for the benefit of other named Beneficiaries according to the terms of the Trust.

10. While the Trustor is living and competent, the Trustee may add money to or withdraw

money from any bank or savings and loan or checking account owned by the Trust without the

11. All personal property transferred into Trust remains personal property and all real

property transferred into Trust remains real property.

12. Unless otherwise indicated to a prospective transferee, the Trustee has full power to

transfer assets held in the name of the Trust and subsequent transferees are entitled to rely upon

such transfers provided the chain of title is not otherwise deficient.

13. The situs of the Trust is the State of Nevada.

14. This Trust contains a spendthrift provision to the extent available under the laws of the

State of Nevada.

controlled as to provisions and interpretations, and any conflict between this certificate and the

Trust shall be decided in favor of the Trust.
