NOTICE OF ASSUMPTION OF ROYALTIES
(Humboldt, Lyon, Douglas and Pershing Counties)

This Notice of Assumption of Royalties (this "Notice"), executed as of December 5, 2022 (the "Effective Date"), is by Sandbox Royalties Corp. ("Sandbox"), a company incorporated and existing in accordance with the laws of British Columbia, whose address is 400 Burrard Street, Suite 1400, Vancouver, B.C. V6C 3A6, for itself and as successor to 1348897 B.C. Ltd. ("1348897").

Recitals

1. Pursuant to that certain Royalty Agreement dated February 14, 2013, M.I.M. (U.S.A.) Inc. granted a royalty (the "Ann Mason Royalty") to Sandstorm Gold Ltd. ("Sandstorm Gold"), covering certain fee and unpatented mining claims located in Lyon and Douglas County, Nevada, as described in the attached Exhibit A (the "Ann Mason Royalty Property"), a memorandum of which was recorded in the official records of Lyon County, Nevada at Document No. 504386.

2. Pursuant to that certain Assignment Agreement dated June 28, 2022, Sandstorm Gold assigned the Ann Mason Royalty to 1348897.

3. Pursuant to that certain Royalty Deed dated June 16, 2020, and recorded in in the official records of Humboldt County, Nevada at Document No. 2020-02302 and in the official records of Pershing County, Nevada at Document 509827 (the "Converse Royalty Deed"), Converse Resources LLC granted a royalty (the "Converse Royalty") to Royalty Consolidation Company, LLC ("RCC") covering certain fee and unpatented mining claims located in Pershing

and Humboldt County, Nevada, as described in the attached Exhibit B (the “Converse Royalty Property”).

4. Pursuant to a Conveyance of Royalty Interests dated March 18, 2021, and recorded in in the official records of Humboldt County, Nevada at Document No. 2021-03975 and in the official records of Pershing County, Nevada at 513197, RCC assigned the Converse Royalty to Royalty Portfolio, LLC (“RP”).

5. Pursuant to that certain Royalty Purchase Agreement dated May 7, 2021 and related Conveyance of Royalty Interests (recorded in the official records of Humboldt County, Nevada at Document No. 2021-03975) and in the official records of Pershing County, Nevada as Document 513717, RP assigned the Converse Royalty to Premier Royalty U.S.A. Inc. (“Premier”).

6. Pursuant to that certain Assignment of Royalty Interest dated June 15, 2022, and recorded in in the official records of Humboldt County, Nevada at Document No. 2022-02547 and in the official records of Pershing County, Nevada at Document 518561 Premier assigned the Converse Royalty to Sandstorm Gold.

7. Pursuant to that certain Assignment of Royalty Interest dated June 16, 2022, and recorded in in the official records of Humboldt County, Nevada at Document No. 2022-02548 and in the official records of Pershing County, Nevada at Document 581562 Sandstorm Gold Ltd. conveyed to 1348897 all of its interest in the Converse Royalty

8. On June 28, 2022, Sandbox (formerly named Rosedale Resources Ltd.) acquired all of the issued common shares of 134887 from Sandstorm Gold pursuant to that certain Share Purchase Agreement dated May 26, 2022 between Sandbox and Sandstorm Gold.

9. On August 12, 2022, 1348897 merged with and into Sandbox, with Sandbox as the surviving entity (the “Merger”). As a result of the Merger, Sandbox acceded to all of the assets of 1348897, including the Ann Mason Royalty and Converse Royalty.
