**FIRST AMENDMENT TO  
CONTRACT FOR PROFESSIONAL SERVICES  
FUNDED FROM FEDERAL FUNDS**

AN AGREEMENT BETWEEN

DOUGLAS COUNTY, NEVADA

AND

PINE NUT CREEK FLOOD MITIGATION FEASIBILITY STUDY

This First Amendment (the "First Amendment") to the Contract for Professional Services Funded From Federal Funds (the "Agreement") is entered into by and between Douglas County, 1594 Esmeralda Avenue, Minden, Nevada 89423, a political subdivision of the State of Nevada (the "County"), and Kimley-Horn and Associates, Inc., 421 Fayetteville Street, Suite 600, Raleigh, North Carolina 27601 (the "Contractor"). The County and Contractor are at times collectively referred to herein as the "Parties" or individually as a "Party."

**WHEREAS**, the Agreement took effect on November 16, 2022, upon being signed by Douglas County Manager Patrick Cates;

**WHEREAS**, the Agreement was recorded with the Douglas County Recorder's Office on November 17, 2022, as document number 2022-991700;

**WHEREAS**, the Parties now desire to amend the Agreement by this First Amendment, correcting a typographical error and clarifying that the Agreement did not terminate on November 21, 2022, and instead continues in effect until no later than November 21, 2023.

**NOW, THEREFORE**, in consideration of the mutual promises and covenants made in the Agreement, which are incorporated into this First Amendment, and the foregoing recitals, the County and Contractor mutually agree as follows:

A. Paragraph 1 of the Agreement is hereby amended as follows:


**1. TERM AND EFFECTIVE DATE OF CONTRACT.** This Agreement is effective on November 16, 2022, and shall continue in effect until all services referenced in the Agreement are performed by the Contractor, but in no event later than November 21, 2023, unless earlier terminated by either party in accordance with the terms of this Agreement.

B. All other terms and conditions of the Agreement not amended by this First Amendment shall remain in full force and effect.



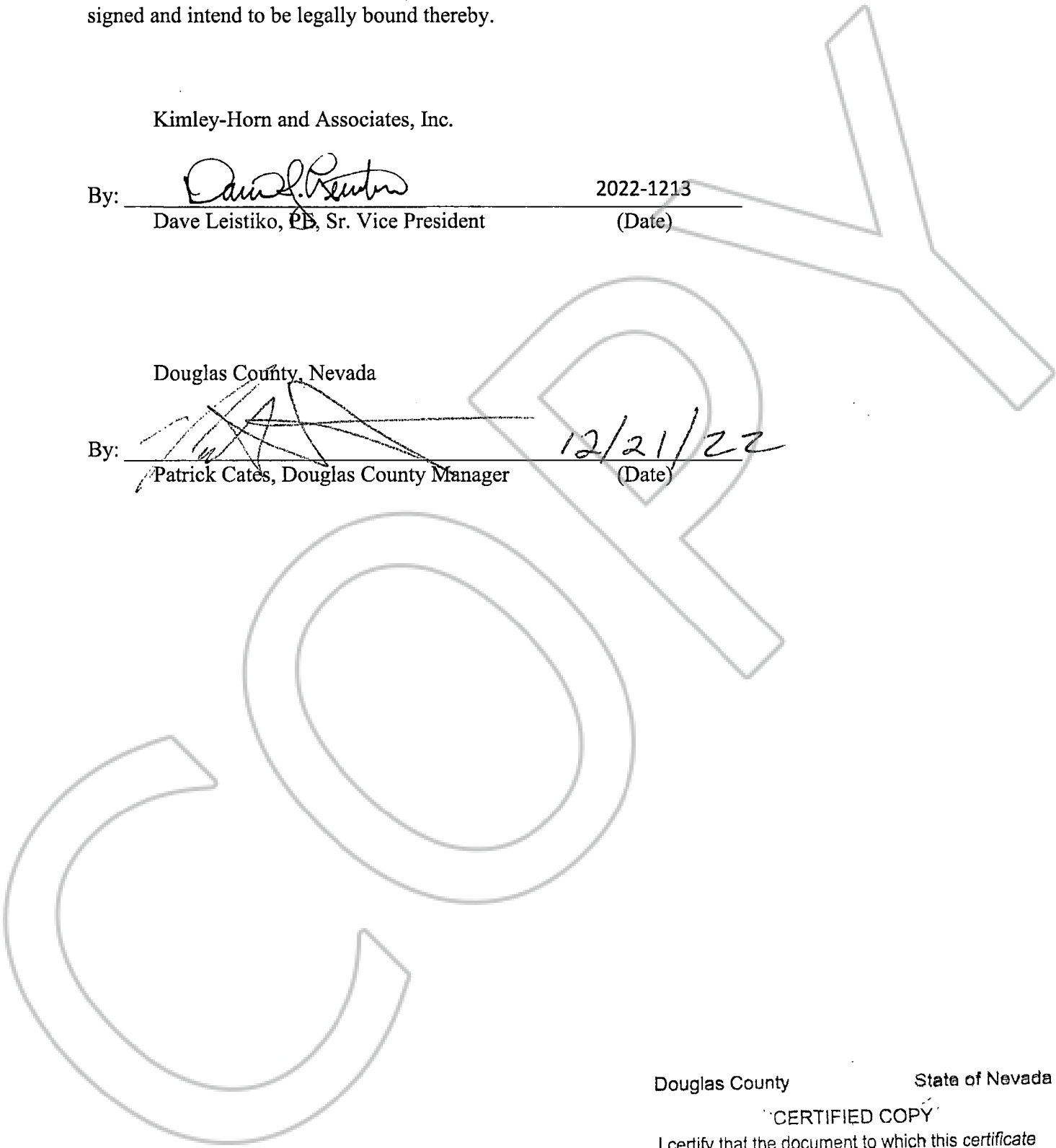


