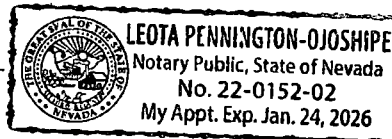

After considering all the evidence, the Master hereby makes the following Findings and Recommendations:

The Obligor is the parent of the following children:

1 Using actual earnings, Obligor's gross monthly earnings are \$5,444.00. Pursuant to the
2 formula prescribed within NRS 125B.080 and NAC 425 et seq., 22% of those earnings,
3 the state calculates an obligation of \$1,198.00 per month.

4 The monthly child support obligation recommended in paragraph 1 below is adjusted
5 based on the following considerations contained in NAC 425.150:

6 The legal responsibility of the parties for the support of others: _____ \$250.00;

7 **RECOMMENDED ORDER IS:**

8 1. Ongoing support is ordered in the amount of \$948.00 per month beginning
9 June 1, 2023. The obligation for Child Support continues until the child turns 18 years
10 of age, or until the child turns 19 years of age if the child is enrolled in High School.
11 NRS 425.300. However, this obligation to support a child is affected by a child's ability
12 to live on their own (NRS129.080 to 129.140 – legal emancipation) or when applicable,
13 continued financial support beyond the age of majority per NRS 125B.110.

14 2. The Obligor is responsible for **child support** arrears for the period of
15 April 1, 2021 through March 31, 2022.

16 A judgment is entered against the Obligor for **child support** arrears as follows:

17 Principal in the amount of \$2,127.58

18 Interest in the amount of \$140.23

19 Penalty in the amount of \$238.10

20 For a total judgment of \$2,505.91 to be repaid at \$25.00 per month beginning June 1, 2023.

21 All payments MUST be made in the form of a money order, cashier's check or business check
22 and payable to **STATE COLLECTION AND DISBURSEMENT UNIT (SCaDU)** and sent
23 to:

27 The following information must be included with each payment:

28 A. Name (first, middle, last) of person responsible for paying child support.

B. Social Security Number of person responsible for paying child support.

1 C. Child support case number 3200033386 listed on each payment.

2 D. Name of custodian (first and last name of person receiving child support).

3 **PAYMENT OF SUPPORT IS TO BE AS PROVIDED HEREIN, AND THE GIVING OF**
4 **GIFTS, OF MAKING PURCHASES OF FOOD, CLOTHING AND THE LIKE WILL**
5 **NOT FULFILL THE OBLIGATION. NOTICE: NO CREDIT WILL BE GIVEN FOR**
6 **PAYMENTS PAID DIRECTLY TO THE OBLIGEE.**

7 3. All payments shall be made by immediate income withholding. If your full obligation is
8 not met by the amount withheld by your employer, you are responsible to pay the
9 difference between your court ordered obligation and the amount withheld by your
10 employer or at any time withholding does not occur, you are responsible to make
11 voluntary payments to the STATE COLLECTION AND DISBURSEMENT UNIT
12 (SCaDU). If you fail to do so you will be subject to the assessment interest. You may
13 avoid these additional costs by making your current child support payments each month.

14 4. The Obligee will cover the children's medical, vision, or dental health insurance
15 needs using either a private for fee insurance plan or public insurance plan. The
16 accessible and reasonable cost of medical support for the children is the amount of \$0.00
17 per month. The Obligor will pay \$0.00 for the monthly medical cash support effective
18 June 1, 2023. NAC 425.135.

19 5. Pursuant NRS 425.382 et seq. and NAC 425 et seq., expenses for health care which
20 are not reimbursed through insurance, including expenses for medical, surgical, dental,
21 orthodontic and optical expenses, must be shared equally by both parents. If a parent
22 seeks reimbursement for a child's medical/dental expense not covered by insurance, that
23 parent must send proof of the expense to the other parent within 30 days of paying that
24 bill. The other parent then has 30 days to reimburse the paying parent 1/2 the cost of
25 that bill. The parents are required to comply with this provision for reimbursement
26 under this provision. The parents seeking enforcement of this provision must either go
27 to small claims court or district court to obtain a judgment against the other parent
28 before CSEP is required to collect that judgment.

1 6. The Obligor shall keep the Division of Welfare and Supportive Services informed of any
2 change regarding current residential and/or mailing address, employment and of access
3 to health insurance coverage in WRITING (including health insurance policy
4 information) within 10 days of such change.

5 7. Effective July 1, 2004 simple interest will accrue on all adjudicated arrears balances
6 (including payment in lieu of medical insurance) and spousal support balances, for cases
7 with a Nevada controlling order pursuant to NRS 99.040. Interest assessed by a
8 judgment of the court prior to July 1, 2004 will be enforced. Interest on the judgment
9 shall accrue at the rate established by NRS 125B.140(2)(c)(1).

10 8. A 10% penalty will be assessed on each unpaid installment, or portion thereof, of an
11 obligation to pay child support for a child, pursuant to NRS 125B.095 until January 31,
12 2020. All penalties accrued through that date will be enforced/collected until the amount
13 is paid in full.

14 9. The State of Nevada has continuing exclusive jurisdiction for enforcement and
15 modification purposes pursuant to the Full Faith and Credit for Child Support Orders
16 Act.

17 10. The Master finds that these Recommendations are in the best interest of the child(ren).

18 It is further ordered that: See page 2, lines 4 through 6. All previously ordered amounts and
19 provisions remain in effect from April 2022 through May 2023.
