CONTRACT AMENDMENT NO. 001

AUGUST 17, 2023 CONTRACT FOR SERVICES BY AN INDEPENDENT CONTRACTOR

between

DOUGLAS COUNTY, NEVADA

and

NATIONAL PLANT SERVICES, INC.

This Contract Amendment No. 001 ("Amendment") is entered into by and between Douglas County, Nevada, a political subdivision of the State of Nevada ("the County") and National Plant Services, Inc., a Foreign Corporation registered with the Nevada Secretary of State ("Contractor"). The County and Contractor are at times collectively referred to hereinafter as the "Parties" or individually as a "Party."

WHEREAS, on August 17, 2023, the County and Contractor entered into a contract to perform services related to providing labor, materials, and equipment to mitigate infiltration in designated manholes by performing curtain grouting; the Contract was recorded as Document Number 2023-999765; and

WHEREAS, in approving the Contract on August 17, 2023, the Douglas County Board of County Commissioners authorized the County Manager to execute any contract and change orders up to \$24,0000; and

WHEREAS, the Parties desire to modify the August 17, 2023 Contract to have the Contractor provide an additional 2.5 days of manhole infiltration mitigation for a total amount not to exceed of \$24,000 for a total contract amended amount of \$99,000; and.

NOW, THEREFORE, in consideration of the agreements herein made, the Parties mutually agree as follows:

- 1. <u>Definitions</u>: Unless otherwise specifically set forth herein, the words and phrases contained in this Amendment shall have the meanings ascribed to them in the August 17, 2023 Contract.
- 2. Services to be Performed: The services to be performed, as set forth in Paragraph 4 of the August 17, 2023 Contract, shall be amended to include an additional \$24,000 of manhole infiltration mitigation.

- 3. The total Contract Price of \$75,000 as set forth in Paragraph 5 of the August 17, 2023 Contract, is hereby increased by \$24,000 to a total of \$99,000.
- 4. All other terms and conditions of the original Contract remain unchanged and in full effect.
