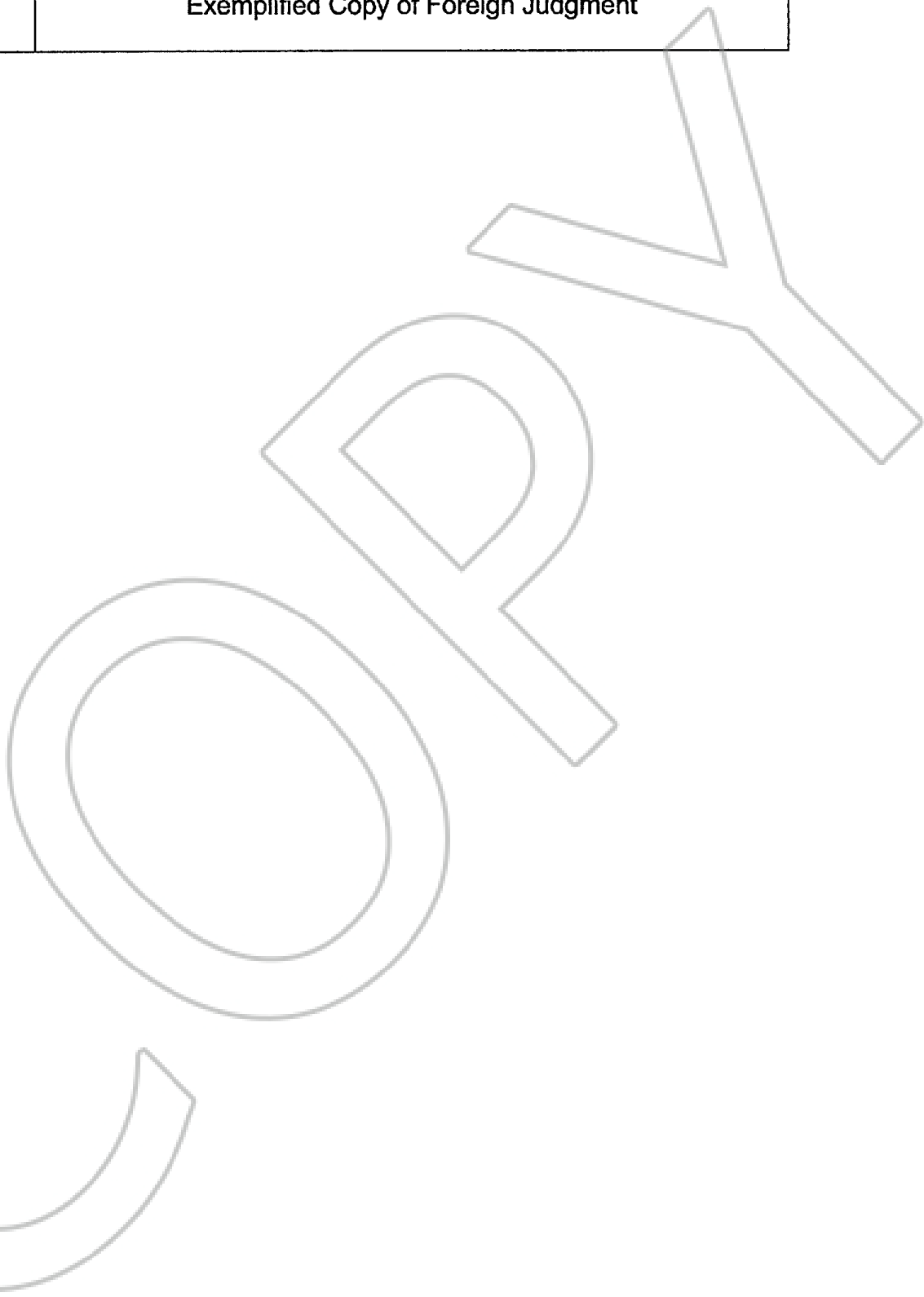

**ORDER ON STIPULATED LUMP SUM PAYMENT OF
CHILD SUPPORT**


THIS MATTER came before the Court via Stipulated Motion for Lump Sum Payment of Child Support filed on April 5, 2022. Petitioner Daskalos was represented by Christina P. Argyres, Respondent Kearney represented himself.

By stipulation of the parties, the Court being fully advised hereby finds as follows:

1. A Judgment against Victor Kearney in the amount of \$189,748.00 (one hundred eighty-nine thousand, seven hundred forty-eight dollars) was entered in March, 2021. This amount will continue to accrue interest at the statutory rate of 4% until paid in full.
2. An additional Judgment against Respondent Kearney in the amount of \$103,080.00 (one hundred three thousand, eighty dollars) was filed in March, 2022. This amount will accrue interest at the statutory rate of 4% until paid in full.
3. Respondent Kearney was held responsible for Petitioner Daskalos' attorney fees in the amount of \$2,500.00 for the March 2021 and 2022 Motion and Order.

4. Respondent Kearney is the income beneficiary of a trust. As a result of certain stock being sold, Respondent had a one-time income gain of eight million four hundred seventy-seven thousand dollars. (\$ 8,477,000.00).
5. Respondent will not likely have an income for future support of his children.
6. The parties stipulate that pursuant to the MSA, Petitioner Daskalos is entitled to receive a judgment in the amount of **\$1,364,797.00** for support of the children as a one time lump sum payment in addition to all other outstanding support owed.
7. Petitioner reserves the right to waive interest if the amounts are paid within 120 days, or interest shall accrue at the statutory rate of 4%.


