WHEREAS, the Contract took effect on June 15, 2023, upon being signed by Douglas County Manager Jenifer Davidson;

WHEREAS, the Agreement was recorded with the Douglas County Recorder's Office on August 10, 2023, as document number 2023-999401;

WHEREAS, the Parties now desire to amend the Contract by this First Amendment, correcting a typographical error and clarifying that the Contract does not terminate on December 31, 2023, and instead continues in effect until the originally negotiated and agreed upon date of December 31, 2024.

NOW, THEREFORE, in consideration of the mutual promises and covenants made in the Contract, which are incorporated into this First Amendment, and the foregoing recitals, the County and Contractor mutually agree as follows:

- A. Paragraph 1 of the Agreement is hereby amended as follows:
 - 1. EFFECTIVE DATE OF CONTRACT. Upon execution by all parties, this Contract shall be effective June 15, 2023, and will terminate on December 31, 2024, unless the Contract is terminated earlier in accordance with paragraph 7.
- B. All other terms and conditions of the Agreement not amended by this First Amendment shall remain in full force and effect.
