ORDER SETTING ASIDE ESTATE WITHOUT ADMINISTRATION

The Court having reviewed the Petition to Set Aside Estate Without Administration in which Gregory V. Holst requests an order setting aside the above estate without administration, this matter having come before the Court on this date, the Court having considered said petition, the file herein, notice of the hearing having been given according to law, and good cause appearing therefor, the Court finds as follows:

- 1. Dana Gerald Bing, Jr., aka D. Gerald Bing, aka D. Gerald Bing, Jr., died on December 8, 2021. At the time of his death, the Decedent left property in Douglas County, Nevada subject to the jurisdiction of this court.
- 2. The Decedent left a duly executed Last Will and Testament dated December 4, 2020, and a Codicil to Last Will and Testament dated June 3, 2021, in which Petitioner is named as Personal Representative.
- 3. The Decedent's Last Will and Testament is self-proving as defined by NRS §133.050.
- 4. Article 2(C) of Decedent's Will, as modified by the Codicil to Last Will and Testament dated June 3, 2021, provides in pertinent part as follows:

- B. I bequeath and devise the residue of my estate to the trustee of that trust designated as the D. GERALD BING, JR. TRUST, of which I am the settlor and the trust agreement for which I have amended this day. I direct that the residue of my estate shall be added to, administered, and distributed as part of that trust, according to the terms of the trust and any amendment made to it before my death. To the extent permitted by law, it is not my intent to create a separate trust by this Will or to subject the trust or the property added to it by this Will to the jurisdiction of the probate court.
- 5. Petitioner is the successor trustee of the D. Gerald Bing Trust dated January 17, 2000 (the "Trust").
 - 6. NRS §146.070(1)(b) provides as follows:

All or part of the estate of a decedent may be set aside without administration by the order of the court as follows: [...]

- (b) If a decedent's will directs that all or part of the decedent's estate is to be distributed to the trustee of a nontestamentary trust established by the decedent and in existence at the decedent's death, the portion of the estate subject to such direction may be set aside without administration. Any portion of a decedent's estate set aside to the nontestamentary trust pursuant to this paragraph is subject to creditors of the estate unless the petitioner provides proof to the court that the trustee has published or mailed the requisite notice to such creditors on behalf of the nontestamentary trust and settlor pursuant to NRS 164.025.
- 7. The assets of the Decedent's estate situated in the State of Nevada and subject to testamentary disposition consist of loans and promissory notes.
- 8. As successor trustee of the Trust, Petitioner has published such notice in Douglas County.
- 9. Pursuant to NRS §146.070(1)(b), the Court should make and enter its order setting aside the Decedent's property to the D. Gerald Bing Trust dated January 17, 2000, after payment of any expenses of last illness, money due to the Department of Human Resources, if any, and Decedent's creditors.

Based on the foregoing findings of fact,

IT IS HEREBY ORDERED THAT:

1. Due and lawful notice has been given of the Petition to the decedent's heirs and devisees pursuant to NRS §146.070 and §155.010.

- 2. The Decedent's Will, as modified by the Codicil, is valid and pours over to the Trust, which is a nontestamentary trust that was in existence at the time of Decedent's death.
- 3. Notice to creditors was mailed to known creditors and published as to unknown creditors on behalf of the Trust.
 - 4. The estate should be set aside and not be administered upon.
- 5. The balance of the Decedent's property, after payment of administrative costs, any money owed to the Department of Human Resources and Decedent's creditors, including the following property:
