- On or about April 29, 2020, Quinn filed a Civil Complaint ("Complaint") 2. regarding the Property against Hjelm, Ticor and GN. The Complaint states the following claims: (1) breach of contract against Hjelm; (2) fraud against Hjelm; (3) fraud against Ticor; (4) breach of implied contract against Ticor; (5) breach of implied contract against Hjelm; (6) breach of fiduciary duty against Ticor; (7) constructive fraud against Ticor; (8) unjust enrichment against Hiclm; (9) civil conspiracy against Hielm, Ticor and GN; (10) quiet title against Hjelm; (11) aiding and abetting fraud against GN; and (12) aiding and abetting breach of fiduciary duty against GN (hereinafter collectively referred to as, the "Quinn Claims").
- On or about October 7, 2020, Quinn caused a Notice of Pendency of Action (Lis Pendens) to be recorded against the Property as Document No. 2020-954014 of the Official Records of Douglas County, Nevada.
- On or about June 2, 2020, Hjelm filed an Answer and Verified Counterclaim against Quinn, and on or about April 8, 2022, Hjelm filed a First Amended Answer and Verified Counterclaim ("Counterclaim") against Quinn. The Counterclaim states claims against Quinn for (1) breach of contract; (2) breach of the implied covenant of good faith and fair dealing; (3) fraud; (4) declaratory relief; (5) quiet title; and (6) partition (hereinafter collectively referred to as, the "Hjelm Claims").
- On or about September 10, 2020, Ticor filed an Answer to Civil Complaint, Counterclaim, Crossclaim and Third-Party Complaint which states the following claims against Quinn, Hjelm, GN and GNCU: (1) interpleader; and (2) declaratory relief (hereinafter collectively referred to as, the "Ticor Claims").

WHEREFORE,

IT IS HEREBY ORDERED, ADJUDGED AND DECREED that the Stipulation is granted in its entirety.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that all of the Quinn Claims and the Ticor Claims are dismissed with prejudice.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that all of the Hjelm Claims, with the exception of the partition claim, are dismissed with prejudice.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that Hjelm's claim for partition is dismissed without prejudice.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that all of the parties shall bear their own attorney's fees and costs associated with this action.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that Quinn's Notice of Pendency of Action (Lis Pendens), filed in this action and recorded on October 7, 2020, as Document No. 2020-954014 of the Official Records of Douglas County, Nevada, is hereby released as to the Property.

IT IS SO ORDERED.
