**TRUST TRANSFER DEED**



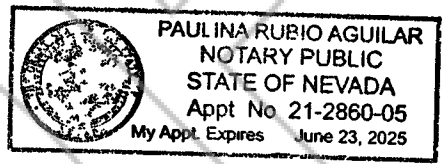


EXHIBIT "A"
