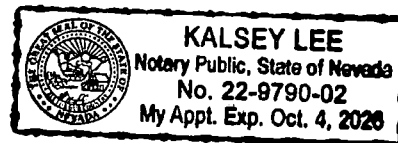

18 This matter was heard on June 9, 2023 for the Notice and Finding of Financial Responsibility.

19 The Court Master with the following were present:

24 After considering all the evidence, the Master hereby makes the following Findings and

25 Recommendations:

26 The Obligor was properly served on March 30, 2023, with a Notice and Finding of Financial
27 and Responsibility.

28 Obligor is the parent of Genesis Vyctoria Saunders, born October 4, 2020.

1 THE RECOMMENDED ORDER:

- 2 1. An arrears Judgment is entered in the amount of \$1,415.00 for August 1, 2021
3 through June 30, 2023.
4 To be paid by payments of \$20.00 per month beginning first month following Obligor's
5 TANF termination.

6 All payments MUST be made in the form of a money order, cashier's check or business check
7 and payable to **STATE COLLECTION AND DISBURSEMENT UNIT (SCaDU)** and sent
8 to:

9 **STATE COLLECTION AND DISBURSEMENT UNIT (SCaDU)**
10 **P.O. BOX 98950**
11 **LAS VEGAS, NV 89193-89501**

12 The following information must be included with each payment:

- 13 A. Name (first, middle, last) of person responsible for paying child support.
14 B. Social Security Number of person responsible for paying child support.
15 C. Child support case number 3200307825 listed on each payment.
16 D. Name of custodian (first and last name of person receiving child support).

17 **PAYMENT OF SUPPORT IS TO BE AS PROVIDED HEREIN, AND THE GIVING OF**
18 **GIFTS, OF MAKING PURCHASES OF FOOD, CLOTHING AND THE LIKE WILL**
19 **NOT FULFILL THE OBLIGATION. NOTICE: NO CREDIT WILL BE GIVEN FOR**
20 **PAYMENTS PAID DIRECTLY TO THE OBLIGEE.**

- 21 2. All payments shall be made by immediate income withholding. If your full obligation is
22 not met by the amount withheld by your employer, you are responsible to pay the
23 difference between your court ordered obligation and the amount withheld by your
24 employer or at any time withholding does not occur, you are responsible to make
25 voluntary payments to the STATE COLLECTION AND DISBURSEMENT UNIT
26 (SCaDU). If you fail to do so you will be subject to the assessment of penalties and
27 interest. You may avoid these additional costs by making your current child support
28 payments each month.
3. The Obligor shall keep the Division of Welfare and Supportive Services informed of any
change regarding current residential and/or mailing address, employment and of access

1 to health insurance coverage in **WRITING** (including health insurance policy
2 information) within 10 days of such change.

3 4. Effective July 1, 2004 simple interest will accrue on all adjudicated arrears balances
4 (including payment in lieu of medical insurance) and spousal support balances, for cases
5 with a Nevada controlling order pursuant to NRS 99.040. Interest assessed by a
6 judgment of the court prior to July 1, 2004 will be enforced. Interest on the judgment
7 shall accrue at the rate established by NRS 125B.140(2)(c)(1).

8 5. The State of Nevada has continuing exclusive jurisdiction for enforcement and
9 modification purposes pursuant to the Full Faith and Credit for Child Support Orders
10 Act.

11 6. The Master finds that these Recommendations are in the best interest of the child.

12 It is further ordered that: Arrears only case, as child has been placed back into the Obligor's
13 home as of June 1, 2023. Prospective interest will not accrue. Obligor to notify the Division
14 upon termination of TANF termination.


19 **ORDER**


