

12 Court that the Petition sets forth facts essential to give this Court jurisdiction to issue Special  
13 Letters of Administration. Good cause appearing therefore;

14 1. The Court grants the Verified Petition to Appoint as Special Co-Administrators  
15 and for Issuance of Special Letters of Administration.

16 2. The Court appoints Kimberley Sharp and Merrill A. Hanson, Esq. as Special Co-  
17 Administrators of the Estate of Haidee Octa Sharp, A/K/A Haidee O. Sharp, and Haidee Octa  
18 Storr Sharp, for the purpose of giving the co-administrators authority to sign and record  
19 Quitclaim Deeds transferring all the Nevada real property interests of the ESTATE OF HAIDEE  
20 OCTA SHARP, A/K/A Haidee O. Sharp, Haidee Octa Storr Sharp, to Kimberley Sharp as trustee  
21 of the Edward L Sharp Trust u/d/t 3/15/2005, along with providing any other supporting  
22 documentation to the County Recorder's Office to effectuate the recording of the deeds.

23 3. The Court orders that Special Letters of Administration be issued to Kimberley  
24 Sharp or Merrill A. Hanson, Esq., without notice or bond, upon the filing of the Oath of Office as  
25 required by law.
