EASEMENT AGREEMENT

- A. Grantor is the owner of certain real property situated in the City of Genoa, County of Douglas, State of Nevada, currently assigned Douglas County Assessor's parcel number 1319-04-002-009, (the "Grantor's Property");
- B. Grantee is the owner of what is commonly known as the Genoa Cemetery, being situated in the City of Genoa, County of Douglas, State of Nevada, currently assigned Douglas County Assessor's parcel number 1319-10-101-009, (the "Grantee's Property"). Grantee's property is due south of and adjacent to Grantor's Property.
 - C. The parties have agreed to the terms and conditions set forth herein.

Based upon the following and for valuable consideration, the receipt of which is hereby acknowledged, Grantor and Grantee do hereby agree as follows:

- 1. Grantor does hereby grant to Grantee, for its sole benefit a perpetual limited access easement described in Exhibits A and B, attached hereto.
- 2. <u>Restrictions on Easement</u>: Grantee shall use the limited easement as described above for the sole purpose of accessing the Genoa Cemetery for installation and maintenance of utilities, for maintenance of trees and plants, gravesites, curbing and landscaping within the Genoa Cemetery. Grantee shall maintain the easement in a fashion that vehicles and mechanized equipment shall traverse the easement for the limited purposes set forth above. Members of the public shall not be authorized to utilize the easement for any purpose whatsoever.
- 3. <u>Amendments</u>: This Easement Agreement represents the full, complete and entire expression respecting the subject matter of this agreement. This agreement

may be modified, amended in total or part, only upon the written consent of the parties hereto. This Easement Agreement shall be considered perpetual in nature and is made expressly binding upon and for the benefit of the parties' heirs, executors, administrators, successors, and assigns.
