## GRANT, BARGAIN AND SALE DEED

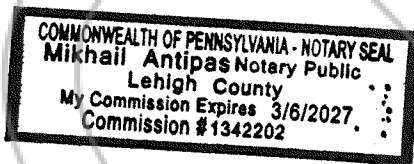
