GRANT, BARGAIN AND SALE DEED

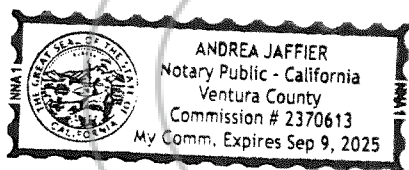


EXHIBIT A- LEGAL DESCRIPTION
