

5 4. That there is no outstanding Writ of Execution for enforcement of the Judgment.


6 5. That NORTHERN NEVADA ANESTHESIA ASSOCIATES, PLLC, has been unable

12 necessary, and actually incurred costs and disbursements in the sum of \$226.00; and




