KNOW ALL MEN BY THESE PRESENTS,

That we Russell L. Siegman of Douglas County as Principal, and Platte River Insurance Company a corporation organized and existing under the laws of the State of Nebraska are held and firmly bound unto, Indian Hills General Improvement District as Obligee in the penal sum of Fifty Thousand and 00/100 (\$50,000) Dollars, lawful money of the United States of America for the payment of which well and truly to be made, said Principal binds himself/herself, his /her heirs, executors, administrators and assigns, and said Surety binds itself, its successors and assigns , jointly and severally , firmly by these presents.

WHEREAS, the said Principal has been elected to the office of Treasurer for a definite term beginning 01/17/2024 and ending 01/17/2025, and is required to furnish a bond for the faithful performance of the duties of the said office or position.

PROVIDED, HOWEVER, that the above named Surety shall not be liable hereunder for the loss of any public moneys or funds occurring through or resulting from the failure of, or default in payment by, any banks or depositories in which any public moneys or funds have been deposited, or may be deposited, any law, decision, ordinance or statute to the contrary notwithstanding.

AND PROVIDED FURTHER, that the Surety may cancel this bond at any time by giving thirty (30) days written notice of its desire to cancel to Obligee, and Surety shall be completely released as to all liability thereafter accruing.
