GRANT, BARGAIN AND SALE DEED

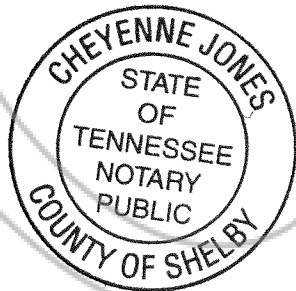


EXHIBIT "A"
LEGAL DESCRIPTION
Ridge Tahoe (Lot 28)

ALL THAT REAL PROPERTY SITUATED IN THE COUNTY OF DOUGLAS, STATE OF NEVADA, BOUNDED AND DESCRIBED AS FOLLOWS:
