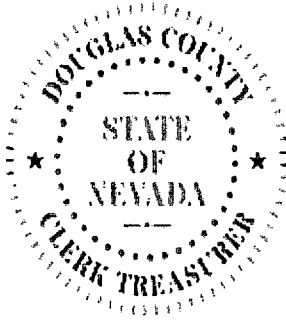

## CERTIFICATION

I, AMY BURGANS, Clerk-Treasurer, of Douglas County, State of Nevada, do hereby certify that the following taxpayers were assessed for the property in Douglas County, Nevada for the year, 2023-2024 and the taxes, not having been paid, became delinquent on March 15, 2024. That, under and by virtue of the provisions of NRS 361.570, I, AMY BURGANS, as Clerk-Treasurer and Ex-Officio Tax Receiver of said Douglas County, State of Nevada, execute this tax certificate authorizing the County Treasurer, as trustee for the State of Nevada and Douglas County, to hold the property described hereinafter for a period of two years after the date hereof unless sooner redeemed. The property described hereinafter is held subject to redemption within two years from the date hereof, by payment of said taxes and accruing taxes, penalties, and costs, together with interest at the rate of ten percent (10%) per annum from date due until paid as provided by law, and such redemptions may be made in accordance with NRS Chapter 21 in regard to real property sold under execution. The title to any property described hereinafter that is not redeemed shall vest in the Douglas County for the benefit of the State of Nevada and said county, and a tax lien may be assigned against said property pursuant to NRS 361.7303 to NRS 361.733, inclusive.

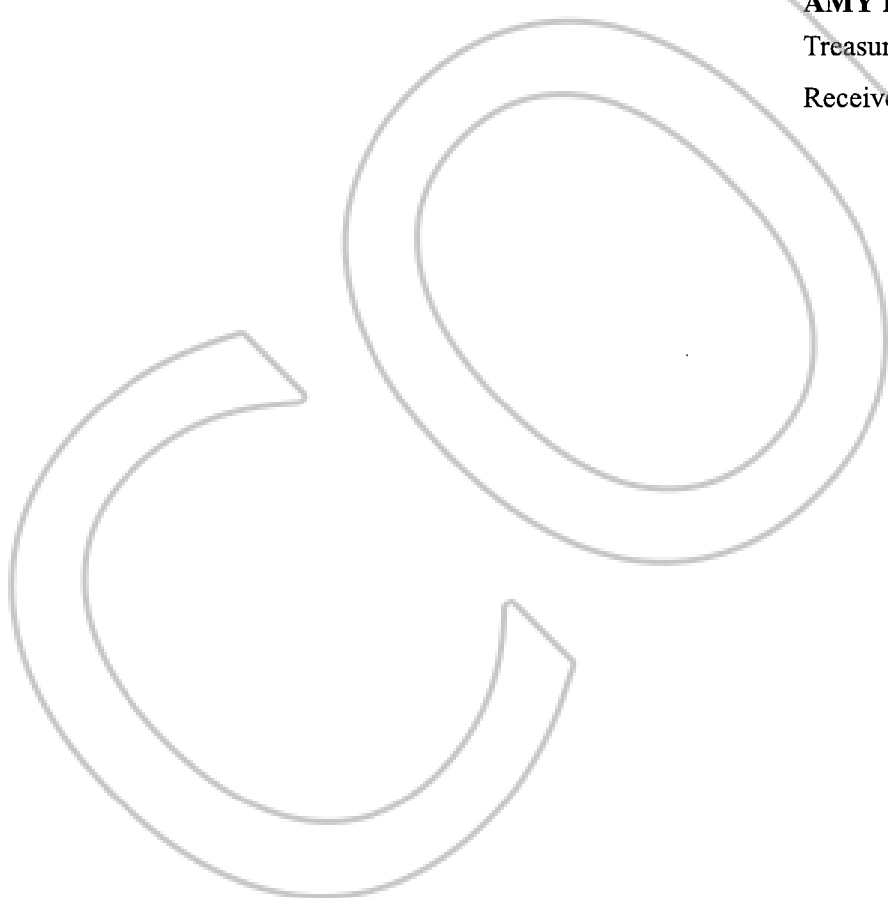
