Farleigh Wada Witt. The court has entered an Order of Default against defendants Growth Stack,
Inc., Kevin Petersen, and Michelle Weldon as Trustee of the Petersen Weldon Living Trust dated
February 21, 2020, and it further appears that plaintiff is entitled to entry of General Judgment and
money award against defendants;
