

## CONTRACT AMENDMENT NO. <u>02</u>

To the Contract for Services by an Independent Contractor - Janitorial Services

between Douglas County

and

QUAL-ECON LLC.

This Second Amendment to the Contract for Services by an Independent Contractor is made between Douglas County, a political subdivision of the State of Nevada ("County") and QUAL-ECON LLC, a Nevada Limited-Liability Company registered with the Nevada Secretary of State (NV20222635721) ("Contractor"). The County and Contractor may at times be referred to herein individually as a "Party" or collectively as the "Parties."

Whereas, County and Qual-Econ U.S.A. Inc, a Nevada Corporation registered with the Nevada Secretary of State (NV19931101236), entered into a Contract for Services by an Independent Contractor with an effective date of August 3, 2020, and that Contract is recorded as document number 2020-949557; and

Whereas, County and Contractor approved Amendment No. 1 to the original contract, effective August 1, 2022, that incorporated the full and complete Exhibit A to the original contract, added and removed facilities and provided a cost adjustment pursuant to the agreement; and

Whereas, Qual-Econ U.S.A. Inc sold their business to QUAL-ECON LLC, effective February 10th, 2023, and the County deemed that the Contractor was duly qualified, equipped, staffed, ready, willing and able to perform and render the services described in the agreement; and

Whereas, pursuant to the terms of the Contract, effective July 1, 2024, the Contractor is entitled to a CPI cost adjustment based on the Western Region CPI published December 31, 2023 with a 5% CPI cap, and the Parties agree that the CPI index was 3.6% and agree to an adjustment of 4% in the Contract pricing.

NOW, THEREFORE, in consideration of the foregoing recitals and mutual consideration, the receipt of which is hereby acknowledged, the Parties agree as follows:

- 1. This amendment shall become effective on July 1, 2024.
- 2. The Parties confirm that neither has expressed an intent to not renew this Contract and that the Contract automatically renewed for a 2-year term as set forth in Paragraph 1 of the Contract. The Parties confirm and agree that, effective July 1, 2024, the contract pricing (detailed in Exhibit B of the Contract) shall be increased by 4% This increase results in an updated annual Contract Price not to exceed <u>Two</u> Hundred and Seventy-Eight Thousand. One Hundred and Seventy-Three Dollars and No Cents (\$278,173.00).
