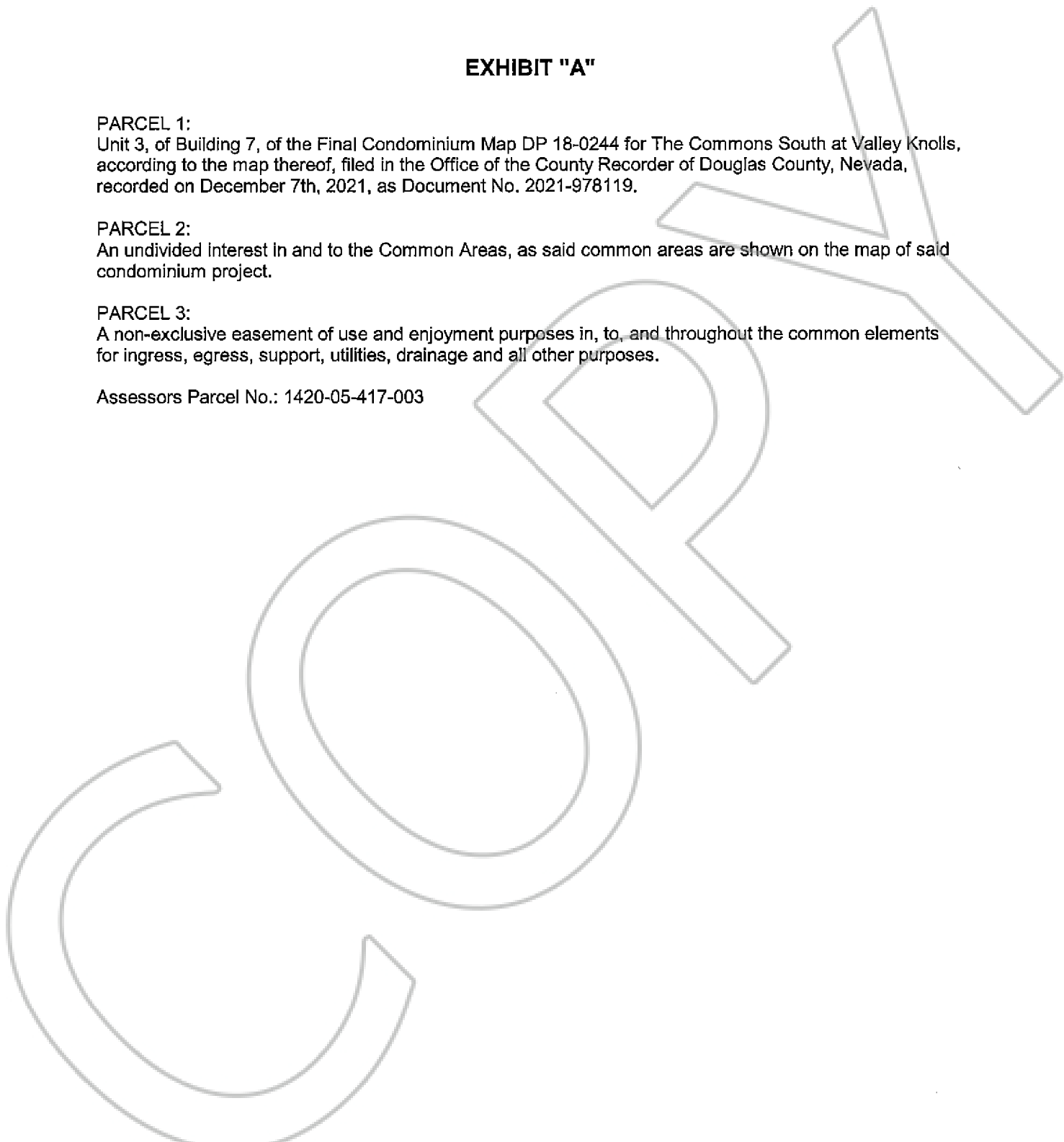
PARCEL 2:
